AN ACT

AMENDING TITLE 38, CHAPTER 3, ARIZONA REVISED STATUTES, BY ADDING ARTICLE 11;
RELATING TO CONDUCT OF PUBLIC OFFICERS AND EMPLOYEES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 38, chapter 3, Arizona Revised Statutes, is amended
3 by adding article 11, to read:
4 ARTICLE 11. INTERNET SERVICE FILTERS
5 38-539. Government provided internet services; content filters;
6 definition
7 A. IF A STATE OR LOCAL GOVERNMENT EMPLOYER PROVIDES ACCESS TO COMPUTER
8 TERMINALS THAT ARE OWNED OR LEASED BY THE GOVERNMENT ENTITY AND THAT ARE
9 EQUIPPED WITH ACCESS TO THE INTERNET, THE GOVERNMENT ENTITY SHALL EQUIP AND
10 MAINTAIN PROGRAMS ON THOSE COMPUTER TERMINALS THAT BLOCK ACCESS TO SEXUALLY
11 GRAPHIC MATERIAL.
12 B. THIS SECTION DOES NOT APPLY TO RESEARCH ACTIVITIES AUTHORIZED IN
13 WRITING BY A GOVERNMENT EMPLOYEE'S SUPERVISOR.
14 C. FOR PURPOSES OF THIS SECTION, "SEXUALLY GRAPHIC MATERIAL" MEANS THE
15 DEPICTION OR DESCRIPTION OF ANY OF THE FOLLOWING:
16 1. SEXUAL ACTIVITY AS DEFINED IN SECTION 13-3501.
17 2. SEXUAL CONDUCT AS DEFINED IN SECTION 13-3501.
18 3. SEXUAL EXCITEMENT AS DEFINED IN SECTION 13-3501.
19 4. ULTIMATE SEXUAL ACTS AS DEFINED IN SECTION 13-3501.
20 5. SANDOMASOCHISTIC ABUSE AS DEFINED IN SECTION 13-3501.
21 6. NUDITY AS DEFINED IN SECTION 13-3501.
