HOUSE BILL 2055

AN ACT

AMENDING SECTION 28-5101, ARIZONA REVISED STATUTES; RELATING TO MOTOR VEHICLE
DIVISION AUTHORIZED THIRD PARTIES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 28-5101, Arizona Revised Statutes, is amended to
3 read:
4 28-5101. Third party authorization
5 A. The director may authorize third parties to perform certain title
6 and registration, motor carrier licensing and tax reporting, dealer licensing
7 and driver license functions.
8 B. A person shall not engage in any business pursuant to this article
9 unless the director authorizes the person to engage in the business.
10 C. The director may furnish necessary documents, license plates or
11 markers subject to this article.
12 D. Except as provided in subsection E of this section, an authorized
13 third party shall submit to the department all statutorily prescribed fees
14 and taxes it collects. In addition to the statutorily prescribed fees and
15 taxes, an authorized third party may collect and retain a reasonable and
16 commensurate fee for its services.
17 E. IN ADDITION TO PAYMENT PURSUANT TO SECTION 28-374, the department
18 shall reimburse the authorized third party AS FOLLOWS:
19 1. One dollar of each registration fee. ~~,-~~
20 2. One dollar of each title fee. ~~and~~
21 3. An amount equal to two per cent of each vehicle license tax payment
22 the authorized third party collects and submits to the department OR FOUR
23 DOLLARS FOR EACH REGISTRATION YEAR OR PART OF A REGISTRATION YEAR, WHICHEVER
24 IS MORE.
25 4. FOUR DOLLARS FOR EACH APPLICATION THAT THE THIRD PARTY PROCESSES
26 AND THAT RELATES TO DRIVER LICENSES, NONOPERATING IDENTIFICATION LICENSES OR
27 PERMITS.
28 5. AN AMOUNT EQUAL TO TWO PER CENT OF EACH OVERWEIGHT OR EXCESS SIZE
29 VEHICLE REGISTRATION OR PERMIT FEE THE THIRD PARTY COLLECTS AND SUBMITS TO
30 THE DEPARTMENT OR ONE DOLLAR FOR EACH OVERWEIGHT OR EXCESS SIZE VEHICLE
31 REGISTRATION OR PERMIT PROCESSED, WHICHEVER IS MORE.
32 6. ONE DOLLAR FOR EACH MOTOR VEHICLE RECORD.
33 7. FIVE DOLLARS FOR EACH TAX REPORT FILING.
